The Board President called the meeting to order.

This would cause difficulty to read and gage the amount of chlorine that is being fed. Since the Hammond Filtration Plant has been using Alexander Chemical there hasn't been any problems with fogging up the chlorinator tubes.

The Board Attorney explained that she felt that this is a good reason to go ahead and award the bid to Alexander, however she has not had time to examine all bids for legalities and felt that it would be a good idea for her to review them before awarding.

The Board agreed with the Attorney. A motion was made by P. Gavrilos, seconded by R. Lendi and motion carried to: table the award of the Spring Chemical Bids until the Board Attorney is able to review them for legality purposes.
