Filtration Superintendent's Report February 10, 2022

Chicago Underwater divers were on site to make two repairs. The first repair was to repair our 42"intake flow meter, which had malfunctioned. The second repair was a more complex repair. There are 6 wires that supply current to our 60"intake heater screens. The initial repair was thought to be only 2 wires when it was discovered that all 6 wires were compromised and needed repairs. This was completed by an underwater splice for each wire. The splice to each of the 6 wires was completed with a design concept by our Operations Supervisor, Rich Madeka. Mr. Madeka will be filing a patent on this underwater connector he designed specifically for this. These power line wires have been providing the 60" intake heaters underwater for 16 years.

Jaime, Mark, Rich and myself met with our engineering firm AECOM, and discussed our repairs to our settling basins in Plant #2. This meeting also included a supplier (AET) of settling tubes and they are interested in providing the equipment specified for the repairs to each of the 4 basins. We will be meeting with other suppliers in the near future.
