The Filtration Superintendent submitted his report as follows:

Filtration Superintendent's Report February 9, 2023

We have registered our water system for the upcoming UCMR 5 testing with the USEPA website regarding testing for PFAS (polyfluoralkyl substances). These chemicals have been man-made since the 1940's and were thought to be beneficial because of their ability to repel fire, water, oil and stains. These chemicals are now known to be a contaminant. These tests will begin in November 2024.

Currently we are updating our Lead and Copper testing sites for the upcoming Lead and Copper revisions that will begin January 2024. We will begin pre-testing some sites using the new testing procedures. The new revisions will include testing at all levels of schools and daycare with known (LSL) Lead Service Lines.

We have met with Jeremy Brown of Leopardo at the plant for a walk through regarding recommendations for energy cost savings.
