On August 15th, HWW management met with reps from Arcadis and Calumet City Plumbing to discuss moving forward with the pilot Lead Service Line project. I am happy to report that Calumet City Plumbing will begin mobilizing into the neighborhood on August 26th. Their plan is to possibly do 2 homes a day.

Mark, Chuck and I had a zoom meeting with Jacobs Engineering concerning a client of theirs' possible relocation to the area. They didn't have much info other than their client needing about 2mgd in order to operate. They were looking for basic questions as to our service area, average pumpage, and if we were able to supply the 2mgd for their clients' operation.

We met with Justin Mount and Indiana American reps on August 19th to circle back to the future inter-connection. Indiana American had done a very early engineering report and reported if we were looking to access 10 mgd from Indiana American,
